Eligibility of Tenderer : This invitation for tender is open to all eligible tenderers as mentioned below :

(A) Reputed Government approved contractors/construction firms who have minimum 5(Five) years of general experience in Construction works.

(B) Having experience in successfully completion/execution of at least 1(one) number of similar nature of building construction work including Civil, Sanitary works worth not less than Tk. Three (3) Crore only in a single work order in Government/ Semi Government/Autonomous Organization of Bangladesh during last 5(five) years.

(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. Six (6) crore fifty (50) Lakh.

(D) The minimum amount of Liquid Assets/working capital/credit facilities/creditline of the tenderer shall be TK. One (1) crore fifty five (55) Lakh only, supported by Bank certificate against the name of the work. Bank statement should be counted 28 (Twenty Eight) days before from the date of opening of tender.

(E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate

(F) Up-to dated ABC category contractory & Supervisory License issued from Electrical licensing Board, Government of Bangladesh.

(G) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.

Special Instructions:

(A) As per latest Amendment of PPR-2008 and according to ITT clause no. 30.3, Tenderers having quoted the tender price more than 10 (Ten) percent above or below the official cost estimate, the tender will be rejected.
