- Eligibility of Tenderer :**
- 1) Reputed Contactors/Construction firms having general experience in Civil & E/M works for minimum Five years.
 - 2) Must have successfully completed at least 1 (One) Two storied RCC building with pile foundation under any Govt./semi Govt./Autonomous Body of Bangladesh during last Five years (counted backward from the date of publication of IFT) amounting at least Tk. 2.40 (Two point Four) Crore in a single contract as a Prime Contractor or Subcontractor or Management Contractor.
 - 3) For works done under PWD, the certifying/authenticating authority shall be the concerned Executive Engineer. For works done under any Govt./Semi Govt./Autonomous Body other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD under whose jurisdiction the work has been done.
 - 4) A minimum average annual construction turnover of TK 5.5 (Five point Five) Crore supported by total certified payment received for work completed under public sector during last Five years.
 - 5) Minimum amount of liquid assets/credit facilities of the Tenderer shall be Tk. 85.0 (Eighty Five) Lac. Adequacy of minimum liquid assets substantiated by any scheduled Bank of Bangladesh as specified in the format (attached with tender document), without any alteration, issued not earlier than twenty eight days prior to the day of the original deadline for submission of Tender.
 - 6) The Tenderer must enclose with tender valid TIN, VAT Registration certificate, Income Tax Clearance certificate, Trade license and up to date ABC license issued by the Electrical Licensing Board of Bangladesh.
 - 7) Tenderers are expected to submit their rates and documents in accordance with ITT Clause 16.1(d), 43.3 & 44.2.
- Other required eligibility and conditions of the tenderer are mentioned in Tender Documents.
