 - iii) The required average annual construction turnover shall be greater than Tk. 1200.00(Twelve Hundred) Lac in the last 5 (Five) years.
 - iv) The minimum amount of liquid asset i.e working capital or credit line(s) of the Tenderers shall be Tk 200.00 (Two Hundred) Lac (adequacy of minimum liquid assets i.e working capital substantiated by any scheduled Bank of Bangladesh in the format as specified (Form PW3-7) (Failing to submit in PW3-7 will make the tender non-responsive).
