 - (b) Having experience in successfully completion of at least one number of similar nature building construction work amounting Tk. 206.00 Lac in a single number of tender/contract in government/ semi-government / Autonomous organisation of Bangladesh within the last 5 (five) years. The experience certificate for successful completion of work shall have to be issued by the officer not below the rank of Executive Engineer, concerned department/ organization duly verified by the concerned Executive Engineer of PWD of that district / area under whose jurisdiction he has been done. Self work will not be entertained for the work experience.
 - (c) The required average annual construction turnover shall be greater than Tk. 900.00 Lac over the last 05 (five) years.
 - (d) The minimum amount of liquid assets i.e working capital or credit line(s) of the Tenderers shall be Tk. 165.00 Lac in the form PW3-7 (Failing to submit in PW3-7 will make the tender non-responsive).
 - (e) The minimum Tender capacity shall be: Tk 250.00(Two Hundred Fifty) Lakh
 - (f) Up-to-date Trade License, Income Tax clearance and VAT Registration Certificate.
 - (g) Up-to-date ABC category contractor and supervisory license for electricity licensing board. Govt. of Bangladesh
 - (h) During evaluation if the quoted rate by any Tendered is found more than 10% less or above than the official estimated price, then the respective tendered will be revoked form the tender.
 - (i) Tenderers may participate in the Tender as JVCA. Maximum number of partners in the JV shall not be more than 2 (two).
